## Scott A. Lay Advocacy Award

In 2009, ILR introduced the Scott A. Lay Advocacy Award and presented it to his surviving family as a memorial to Scott's vision and leadership for Oregonians.

ILR is seeking nominations for candidates to receive this award in 2010. Candidates should demonstrate leadership on behalf of people with disabilities in Oregon.

Nominations will be accepted through 5 p.m., Sunday, August 15<sup>th</sup>.

## Nomination Instructions

### Eligibility:

- ❖ Most community members may be nominated for the Scott A. Lay Advocacy Award \*
- \* (1) Sitting members of ILR Committees, Board Members, and staff are not eligible.
- \* (2) The current Scott A. Lay Advocacy recipient is not eligible for two years.

### Format:

- ❖ All nominations must be completed on the official nomination forms, available at [www.ilr.org](http://www.ilr.org) and at the ILR Office. Please let us know if you need an alternative format.
- ❖ Typed entries are strongly encouraged. Attach additional sheets as needed.
- ❖ Please limit nomination forms to no more than THREE pages, double-spaced.

### What to Include:

- ❖ Nominations should demonstrate excellence in **one or more of the four categories**.
- ❖ Nominations should be detailed and specific, **providing examples** wherever possible.

### Of Note:

- ❖ The Selection Committee will hold all nominations in confidence.
- ❖ Nominations may be resubmitted in subsequent years, but nominations will not be carried over automatically.

### Deadline:

- ❖ Completed nominations are due by 5:00 p.m. on Sunday August 15<sup>th</sup>, 2010 to ILR.
- ❖ *There will be **NO EXCEPTIONS** to the nomination deadline.*
